

FACTS WHAT DOES CETERA INVESTMENT SERVICES DO WITH YOUR PERSONAL **INFORMATION?**

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some, but not all, sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	 The types of personal information we collect and share depend on the product or service you have with us. This information can include: social security number and birth date income, assets, net worth and credit history account balances and transaction history
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Cetera Investment Services chooses to share; and whether you can limit this sharing.

Who is providing this notice?	Cetera Investment Services LLC, Cetera Investment Advisers LLC, Cetera Insurance Agency LLC
What We Do	
How does Cetera Investment Services protect your personal information?	 To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. In addition to physical and electronic safeguards, we have implemented security standards and procedures to protect your information, including employee training, limited employee access and the use of confidentiality agreements.
How does Cetera Investment Services collect my personal information?	 We collect your personal information, for example, when you: open an account or deposit money direct us to buy or sell securities seek advice about your investments or enter into an investment advisory contract We also collect your personal information from other companies.
Why can't I limit all sharing?	 Federal law gives you the right to limit only: sharing for affiliates' everyday business purposes – information about your creditworthiness affiliates from using your information to market to you sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account.
Definitions	
Affiliates	 Companies related by common ownership or control. They can be financial and nonfinancial companies. Our affiliates include companies with a Cetera name; and financial companies such as First Allied Holdings companies, The Legend Group, Summit Financial Services Group, Investors Capital Corp., VSR Financial Services, Inc., Girard Securities, Inc., J.P. Turner companies and Tower Square Investment Management.
Nonaffiliates	 Companies not related by common ownership or control. They can be financial and nonfinancial companies. Our nonaffiliate partners include categories of companies such as financial institutions.
Joint Marketing	 A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Our joint marketing partners include categories of companies such as financial institutions.

Other Important Information

- If your account was opened at a financial institution, and that financial institution decides to transfer to a new financial services provider, we may share your information with the new provider so that your account may continue to be serviced. If the advisor of record on your account is not: (i) affiliated with a financial institution; (ii) an employee of Cetera Investment Services; or (iii) otherwise restricted from contacting former clients, that advisor may retain your personal information, in electronic and/or paper form, when leaving to join another firm, so that he/she may continue to service your account.
- Accounts with a California, Vermont, Massachusetts, Maine, Alaska or North Dakota mailing address are automatically treated as if they have limited the sharing as described on page 1, and account information will not be shared in connection with a financial advisor transition as described above, unless we receive your written consent.
- <u>California residents</u>: We will not share your personal information with a financial company for joint marketing purposes except as required or permitted by law.
- <u>Vermont residents</u>: For joint marketing with other financial companies, we will disclose only your name, contact information, and information about your transactions, unless otherwise required or permitted by law.
